# Statement of Service Performance What did we do, When did we do it? For the Year Ended 31 March 2022

#### **OUTCOMES**

a. To provide a community and network which informs, connects and supports the NZ Tuberous Sclerosis Complex (TSC) community (individuals with TSC, their families and health professionals).

#### **OUTPUTS**

- **a.** Maintaining a mailing list of 64 individuals, families, professionals and supports in the TSC community including 9 health professionals and 2 organisations.
- **b.** TSCNZ marked global awareness day campaign on 15 May 2021 with supporting NZers to attend TS Australia's online conference. 5 community members and 2 health professionals were sponsored to attend.
- **c.** TSNCZ sponsored one NZer to attend TS Australia's TAND+ event online on 20th November.
- **d.** TSCNZ published 800 Parachute Packs (information for families and individuals with a new TSC diagnosis) and 200 copies of information on the updated Surveillance and Management Guidelines for TSC. The packs were posted out to the TSC community and 150 medical services working with the TSC community.
- **e.** Sharing advice from TS Alliance on Covid vaccination and management in individuals with TSC.
- **f.** Three email newsletters and two physical newsletters and issues of Reach Out magazine were sent to members and supporters in the TSCNZ network.
- **g.** Information packs including brochures on TSC, surveillance and management guidelines, TAND checklist were sent to 3 newly diagnosed families. 13 Individuals needing support were given information, connected with others with relevant experience by phone or online.

- h. TSCNZ supported Rare Disorder NZ's advocacy efforts to increase funding for Pharmac and recognise Rare Disorders in the health restructure. TSCNZ made submissions of the Pae Ora (Healthy Futures) Bill and Pharma's Covid Anti-viral proposal.
- i. TSCNZ attended meetings of the Neurological Alliance.
- j. We maintained our international relationships with TSCi and TS Australia.
- **k.** The management committee met 5 times via teleconferencing and once in person to exchange information, views and ideas and administer the society. We welcomed Tom Maling and Kaitlin Pearson to the committee and regretfully accepted the resignations of Leah Bos and Ryan Powell.
- I. The AGM was held on at Crave Café in Auckland and on Zoom on 1 August. This combined with the launch of our Parachute Packs and a grateful farewell to Leah Bos for her 7 years service as a committee member.
- **m.** Support and updates on the society activities were provided on the facebook pages https://www.facebook.com/TSCNZ (414 likes up from 364) and https://www.facebook.com/groups/AuTSC. Instagram, Twitter and LinkedIn accounts were activated. As of April 2022 followers were: LinkedIn 3 Instagram 18 Twitter 24.
- **n.** The society was successful in attracting financial support through donations and fundraising totalling \$13,641. Special thanks to the family and friends of Jo Maling and Industrial Tube Limited for their generous donations.
- **o.** TSCNZ supported local TSC research through publicising the NZ topical sirolimus trial and supporting Ryan Powell's application to ClinVar to register a new genetic variant he discovered of TSC.

The committee has put many volunteer hours into making these achievements happen and I would like to thank them very much for their dedication. We always welcome new volunteers. Please contact us if you have some time to offer TSCNZ! E waka eke noa.

Tuberous Sclerosis Complex New Zealand (the Society) is an unincorporated society registered as a charitable entity with the Charities Commission under the Charities Act 2006.

The financial statements of Tuberous Sclerosis Complex New Zealand have been prepared in accordance with the Not-for-Profit framework, Tier 4, issued by the New Zealand Accounting Standards Board of the External Reporting Board.

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on cash basis have been used, with the exception of certain items for which specific accounting principles have been identified.
